Item 6. Presentation by the Honorable Patricia A. Barrera, Webb County Tax Assessor-Collector on the 2025 Truth-in-Taxation Calculation.

The Honorable Patricia Barrera, Webb County Tax Assessor Collector, gave a verbal report on the 2025 Truth-in-Taxation Calculation and the corresponding worksheet.

She informed the members of the council that the 2025 No New Revenue Tax Rate was \$0.578128 with a corresponding tax levy of \$375,492.50. She also informed the members of the council that the 2025 Voter Approved rate was \$0.578920 with a corresponding tax levy of \$376,006.90.

Item 8 .Discuss, consider and take appropriate action on authorizing the city's management team to declare specific city-owned property as surplus and authorize its disposition in accordance with applicable state laws and city policy as provided in the Local Government Code § 253.008 and Texas Government Code § 2175.304 through one or more of the following methods:public auction, competitive sealed bids, intergovernmental transfer or donation to another government entity or nonprofit organization, recycling or scrapping if no other value can be recovered; and any other matters incident thereto. After several discussion related to operational costs associated with the motor vehicle expenses for the El Cenizo Community Volunteer Fire Department, a motion to internally transfer a ford explorer from the El Cenizo Police Department fleet to the city's Fire/Emergency Services fleet was made by Commissioner Valdez and seconded by Mayor Hernandez. The motion was approved 2-0-1 with Commissioner Perez abstaining.

Commissioner Valdez moved to approve the declaration of surplus property with the exception of the brown crown victoria and public auction of the Tahoe Interceptor giving full authority to the city secretary for disposition in accordance with applicable state laws and city policy. The motion was seconded by Commissioner Perez and approved without objection.
